Introduction

The **Business-Oriented Boilerplate** and **GuideBook** products are offered under two types of licenses. By choosing the appropriate license, you confirm that you accept the terms set forth in this document. Below are detailed descriptions and conditions for the use of each license:

- Standard License
- Client Work License

1. Standard License

a) Scope of Granted Rights

- **Right to Use:** The user is granted a non-exclusive, non-transferable right to use the Products within their own projects.
- Modification: The user may modify the Product to adapt it to their own needs. However, such modifications may not serve as a basis for further distribution or resale of the Product as a standalone item.
- Integration: The Product may be used as an element of larger projects, provided it is not offered as a separate product sold or made available to third parties.

b) Restrictions

2. Client Work License

a) Scope of Granted Rights

- Right to Use: The user is granted a non-exclusive, non-transferable right to utilize, modify, and adapt the Products within projects executed on behalf of clients.
- Integration in a Project: The Product may be incorporated into comprehensive solutions created for clients, provided it is not offered as a separate, standalone product.
- Customization for Client Needs: The user has the right to modify the Product to tailor it to the specific requirements of a project executed for a client.

b) Restrictions

- **Prohibition of Standalone Resale:** The license does not authorize the sale, sharing, or further distribution of the Product as a separate item, regardless of any modifications made.
- Retention of Copyright: Despite modifications and adaptations, the
 copyright of the original Product remains the exclusive property of FlyUp.
 Any solutions based on the Product do not need to include information
 about the source and the license.
- **Scope of Use:** The license is limited to projects executed on behalf of clients. Any use of the Product outside the direct project commissioned by a client requires obtaining appropriate consent from FlyUp.

3. Final Provisions

- License Selection: The choice of the appropriate license is binding at the moment of purchase of the Product. Using the Product under conditions other than those specified in the chosen license will be considered a violation of these terms.
- **License Modifications:** FlyUp reserves the right to introduce changes to this licensing document. All changes will be published on the FlyUp website and will take effect from the date of publication.
